





### **2022 Continued Pandemic Impact**

With the lessening of pandemic restrictions on travel and other restriction, the in-person attendance increased with each meeting which directly impacts revenue from sponsorship and registrations.

- N84 Austin In-person attendees: 466, Sponsors \$338K, Total Revenue \$591.8K, Expenses \$564K, Net Income \$27.5K
- N85 Montreal In-person attendees: 514, Sponsors \$488.5K, Total Revenue \$729.8K, Expenses \$467.4K, Net Income \$262.3K
- N86 Hollywood In-person attendees: 930, Sponsors \$757.7K, Total Revenue \$1.3M, Expenses \$783K, Net Income \$583.4K




## **Economic Impact**

- Offsetting the positive direction in meetings, was the negative impact on the market.
- The financial impact on the P&L was a loss of \$508K in investments.
  - Unrealized loss on  $\bigcirc$ investments of \$373K
  - Realized capital loss of Ο \$135K








### Rank choice voting





