












Income and Expenses



Summary

- Board approved using Single Transferable Vote method
- Used the <u>config defaults of Simply Voting</u> (our vendor)
- Reproduced the results off the platform using code developed from <u>pyrankvote</u>
- 6 candidates accepted nominations
- 1 candidate withdrew before the start of the election
- 2 candidates were elected in 5 rounds



Things that went well

- We implemented STV as requested
- We kept the membership informed
- The candidate forum was a success
 - Non-attending candidate's pre-recorded video played correctly
 - The committee's questions elicited substantive responses
 - Participating members asked additional pertinent questions



Areas for improvement (1 of 2)

- A board skills/experience/diversity gap analysis would help attract suitable candidates
- The 2024 Committee should investigate which version of redistribution to implement so the counting method aligns with most voters' expectations
- The NANOG Board should consider if the 2024 Elections Committee members need to sign an NDA



Area for Improvement (2 of 2)

- Call for Board candidates should clarify that travel expenses are not reimbursed
- Improve navigation to the voting page
- Set candidates' expectations for process
